NB: In addition to the above

- Students who came from other than the University of Dhaka are required to complete their registration process to the University of Dhaka. For that purpose, they will have to pay an additional BDT 7,000/- to the University of Dhaka.
- For every semester, each student would need to pay BDT 2,250/- as examination fees to the University of Dhaka.

Availability of Financial Assistance/ Permium/ Scholarship

- BCS cadre and class-I gazetted officers are needed to pay only 25% of the total cost.
- After successful completion of the 1st semester and onwards, if a (Non-Govt.) student achieves CGPA 3.75 and above in the scale of 4.00 the student will be eligible for 50% waiver of the tuition fees.
- After successful completion of the 1st semester and onwards to the other semesters, if a (Non-Govt.) student achieves CGPA 3.50 to 3.74 in the scale of 4.00, he or she will be eligible to get 20% waiver on the tuition fees.
- If a (Non-Govt.) student deposits the whole amount at a time, 25% (Tk. 28,125/-) waiver on total tuition fees will be awarded to him/ her.

Documents required:

- All educational certificates in original will have to be shown at the time of admission;
- All BCS Cadre officers & Class-I Gazetted officers will have to submit the following documents as a testimony to their present position:
 - Certified copy of the letter of Appointment/Gazette notification & letter of last posting;
 - Permission of study from the authority concerned/a copy of the application for permission; and
 - 03 Copies of Passport Size Photo & Migration certificate (original certificate)
- All academic certificates duly attested by Class-I Gazetted Officer/Principal/Bank Manager of Notary Public to be submitted to the admission office; and
- Registration forms shall be duly completed along with the migration certificates for those who are from different Universities other than Dhaka University.

- Saturday and Sunday from 1 p.m. to 8.00 p.m.
- During other working days from 9:00 a.m. to 4:00 p.m. (Except Friday)

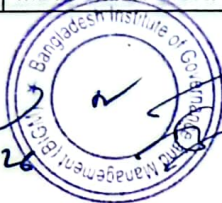
